Course Description: PRT 3207 will take a systematic approach to management in the parks, recreation and tourism industry. Students will analyze contemporary issues and practices, and trends that transform the way employees in the parks, recreation and tourism industry are managed. The course will include the basic principles and practices of management in parks, recreation and tourism agencies. These include planning, organizing, coordinating, staffing, directing, controlling, and evaluating. In addition, this course will focus on the roles of PRT managers in relation to human resource issues, motivation, and leadership.

### NRPA/AALR (Professional) Accreditation Standards that are covered in this course:

Students graduating from the program shall be able to demonstrate entry-level knowledge about management/administration in parks, recreation, tourism and/or related professions.

Knowledge of park and recreation management and administration.

## Performance-Level Knowledge

- Ability to implement human resource management procedures and policies, including staffing (recruitment, development, retention, separation), labor law, ethics, personnel action, communication of benefits, training)
- Ability to use quality assurance and quality management procedures
- Ability to communicate effectively, both orally and in writing, with internal and external stakeholders, customers, consumers, and associates
- Ability to use knowledge of business ethics, including developing and enforcing codes of conduct, recognizing bases for ethical decision making, and conducting stakeholder analyses

• Ability to use park and recreation foundations knowledge for making reasoned decisions and interpreting those decisions to boards and community leaders.

## <u>Understanding-Level Knowledge</u>

- Ability to describe the various legal foundations authorizing park and recreation service delivery; e.g., enabling legislation, special districts.
- Ability to describe basic human resources management concepts, principles, and procedures
- Ability to describe community outreach concepts, principles, and procedures
- Ability to describe political processes and political advocacy
- Ability to describe the composition, appointment, authority, and responsibility of boards and commissions
- Ability to describe how management personnel should interact with boards and commissions

**Teaching & Learning Methods:** This course is designed with weekly lessons with specific components for the specialization cohorts. The students will need to select one of the specialization cohorts by the second week of the semester. The Cohort Modules will include specific applications, supplemental resources, and recorded interviews/discussions with professionals working within the industry related to your specialization. The course assignments and discussions will be conducted among the cohorts, so you will be working with the students and professionals that share your interests. The Cohort Modules will include:

- Adventure, Outdoor/Natural Resource Management Cohort
- Hospitality Management Cohort
- Commercial Recreation & Sustainable Tourism Management Cohort
- Community & Sport Management Cohort
- Therapeutic Recreation Management Cohort

Each learning module will include a study guide, required reading, recorded lecture, printed lecture notes, supplemental resources, and related assignments. Several modules will feature recorded interviews/panel discussions with marketing experts and/or videos from the American Hotel & Lodging Associations.

**Optional Certification:** Students may elect to earn the American Hotel & Lodging Association/Educational Institute (AHLA/EI) Certification. This will be particularly of interest to students in a future hospitality management career. The "Hospitality Cohort" modules have been designed to assist students in achieving the AHLA/EI certification.

Required Textbook: The only students requiring a textbook are those students pursuing the optional AHLA/EI Certification. These students will need to purchase a key code for the online AHLA textbook and the certification exam. The key codes are available at the Campus Bookstore for \$75.00. This is represents a significant savings over the standard purchase of a hardbound textbook and the AHLA exam scantron. You will **not** need to purchase the AHLA exam scantron.

# **Course Requirements and Assignments:**

**PARTICIPATION:** Participation points are earned by actively engaging and contributing positively to the community learning environment shared by all students. Active and positive contributions during class exercises and discussion consists of accessing the course materials with sufficient time to complete the readings, lectures, assessments, and/or assignments prior to the deadlines, asking thoughtful and probing questions on the discussion board, and generally positive contributions to the learning environment.

**REFLECTION ASSIGNMENTS:** Following several lectures there will be interactive assignments designed to provide an opportunity to reflect on what you have learned, examine your own attitudes and beliefs regarding the topic, or to explore resources available on the Internet or in your community. There are 3 types of these reflection assignments: Discussion Board postings, Individual Written Assignments, and Team Projects. These assignments are due the Friday (12 noon) following the week assigned, unless otherwise noted.

- **Discussion Board Postings:** Reflection questions will be provided for each assigned discussion board topic related to the corresponding week's topic in an effort to facilitate open discussion. Please note that students will be evaluated according to the Review Rubric. The key to earning the full points available is based on your ability to integrate what you have learned on the topic through the readings, lecture, and study questions.
- Assignment Page Submissions: All submissions on the Assignment page require documents to be typed on a word processor and submitted as an attachment on the Canvas Assignment Page. You are responsible for preparing a quality document in a format that can be opened and read by the instructor. Therefore, you should use Microsoft Word 2003 or 2007 and save your files with a ".doc" or ".docx" extension. If you use any other software then we request that you save your file in Rich Text Format (".rtf") or in Adobe Reader format (".PDF"). If you submit any other type of document you will earn a zero for the submissions. Please Note: Any assignment or discussion found to contain a significant amount of material copied from a published document or from the Internet without the appropriate citation will be receive zero credit. Plagiarism will not be tolerated.
- Cohort/Team Projects: All students will be provided an opportunity to join a cohort of students that share similar interests/emphasis specialization. Team members should share similar career interests and availability for team meetings via Canvas Chat, Discussions via Canvas, and mail messages via Canvas. Teams will be encouraged to collaborate using the Canvas Chat, Google Docs, DropBox, or similar tools of your choice. Instructional guidelines will be provided for the aforementioned tools.

**QUIZZES/EXAMS:** There will be weekly timed quizzes during the semester designed to ensure your comprehension and retention of key points from the chapter and lecture. These are designed to help you achieve success on the final/certification exam and to evaluate your comprehension/retention of the material. Format for the exams will include multiple choice, matching, short answer, and essay or application problems. A variety of study tools are available on the Canvas to assist students in preparing for the exams. You will be allowed multiple attempts of the weekly quizzes, but the final exam will be an exam with only one attempt. Only excused absences will be accepted for approval of make-up exam.

Further details regarding the assignments for this course will be made available on the first day of the course via the PRT 3207 Canvas Assignment Page.

## **Grading Policy:**

It is the student's responsibility to ensure that all assignments and assessments are completed in a timely manner. All deadlines for the assignments and assessments have been posted on the Canvas Calendar. Please note that all late assignments will be deducted 10% per day late or portion of day late. **Final Exams:** It is against University policy to give final exams at a time other than the scheduled periods for final exams. All conflicts with other exams must be resolved with the course instructor at least two weeks prior to the final exam.

**Incompletes:** University policy states than an incomplete may be given only when the student has passed at least 80% of the course work.

### **Late Assignment Submissions:**

This online course has set due dates for all assignments, assessments, and discussions. All submissions are due at 12 noon on the date assigned. Any assignment received even one minute after the deadline or later will be considered late. The Canvas clock is the final word on the time "stamp" on assignments, assessments, and discussions. All late submissions will be penalized 10% per day or portion of day late. No assignment will be accepted that is over 7 days late. The only exceptions to this policy are those due to officially sanctioned University activities, religious holidays, and illness with medical documentation. Additionally, no late assignments are accepted after the first Monday of the last full month of the semester even if the due date occurs during the last month of the semester (Fall: November 5, 2012). **Minimum Grades:** Grades of "C-" or better must be earned in major or allied field courses for the course to count toward completion of the major.

### **Student Absences:**
